### **The Neurology of Lower Extremity Adjusting and Common Foot Patterns**

This presentation will begin with the basic neurology of extremity adjusting. This will explain the benefit of primarily utilizing indicators to adjust extremity articulations as opposed to symptomatology. This will be covered by the concept of "The Noisy Joint".

Then, utilizing motion x-rays, and video demonstrations, the adjustments for the typical pronated foot will be taught. These adjustments include the navicular, cuboid, cuneiforms, talus, calcaneous, and fibular head. Next, the indicators, listings and adjustments for the knee will be presented. The wrist extension thrust technique will be covered in great detail so participants will be able to duplicate the results. Following the foot and knee, a targeted rehab exercise will be shown. The final portion of the seminar will consist of the indicator, adjustment and rehab exercise for the typical hip.
