Workers Compensation Updates: HP-1, PAR process, and new forms needed for patient care

Friday, Sept 29, 2023 | 2pm-4pm

This course will cover: Accessing the NYS WCB OnBoard system and start the HP-1 process; Responding to C8.4 denials for concurrent care with an HP-1; Accessing the NYS WCB OnBoard system and the PAR process

Guideline clarifications for when a PAR is needed.; How to currently re-open a case with elimination of C-27 and C-25 forms and new form RB-89 replacing and proper completion of the form; Mandatory electronic submission of all claims (no more faxes) and how email and setup electronic billing for NYS WC claims

Dr. Stein and Dr. Merckling are 2002 graduates of New York Chiropractic College and each maintains a private practice on Long Island. Both Dr. Stein and Dr. Merckling are active members of the NYSCA Insurance Committee and serve as NYSCA Region 2 Directors.

Chronic Spine Pain and Rehabilitation

Friday, Sept 29, 2023 | 4pm-6pm

As health care continues to be an economic burden, care delivery will be assessed by one word: value. For spine, these costs and expectations are not going to be an exception. The costs for treating chronic disease, and spine pain in particular are staggering. Chiropractic can be a valuable tool for providing cost-effective value based effective care, but it is an underused resource. Each spine specialty will likely be subjected to offering care which will be reimbursed based upon the value it offers.

The attendee will understand the basic concepts of evidence based medicine. We will introduce the different types of studies and grading of their quality. We will discuss the pertinent statistics and validation measures. We will do an online demonstration on utilizing PubMed to access peer reviewed journals. At



the end the attendee will understand how to access quality peer reviewed information and how to incorporate it into their practices.

This is the fourth class (hour 5/6) for a completion certificate.

Dr. David Kartzman is a 1989 graduate of New York Chiropractic College. He has been in private practice in Corning, NY since 1990. His particular interest of care is working with chronic spine pain patients. In addition to being a NYSCA member since 1990 he is also a member of the North American Spine Society, serving on their Interdisciplinary Spine Section. His most recent venture is the establishment of a NYSCA ad hoc sub-committee on Chronic Spine Pain and Rehabilitation.

Dealing With Chronic Spine Pain: Key Lab Markers and Nutritional Issues

Saturday, Sept 30, 2023 | 8am-12pm

Many chiropractic patients respond very well to manual care. This class is about non-responders with chronic pain and depression who need additional management strategies, particularly related to nutrition and lifestyle. Non-responders are typically inflamed and unhealthy and suffer from various chronic conditions in addition to pain, such as depression, chronic fatigue, irritable bowel syndrome, and hypertension. Nutritional management and proper documentation during the course of care will be highlighted.

David R. Seaman, DC, MS, DABCN, is a Professor of Clinical Sciences at National University's Florida Campus in Pinellas Park, where he teaches E&M courses for the musculoskeletal, cardiorespiratory, gastrointestinal and genitourinary systems. He is also a faculty member for National's Masters of Science program in Advanced Clinical Practice.

Dr. Seaman is a graduate of Rutgers University and New York Chiropractic College. He then received a Masters degree in Nutrition from the University of Bridgeport and a diplomate in neurology through Logan College of Chiropractic.

We will be covering multiple primitive reflexes that are crucial to development in the first years of life and the implications of lack of integration in older children. A complete Applied Kinesiology pediatric exam will be described and adjusting styles and the appropriate amount of pressure that is warranted per age group will be discussed. Finally, we will cover some of the most recent and pertinent research regarding safety and efficacy of pediatric patients in the chiropractic office including the types of cases we can make the most difference in through primitive reflexes and Applied Kinesiology.

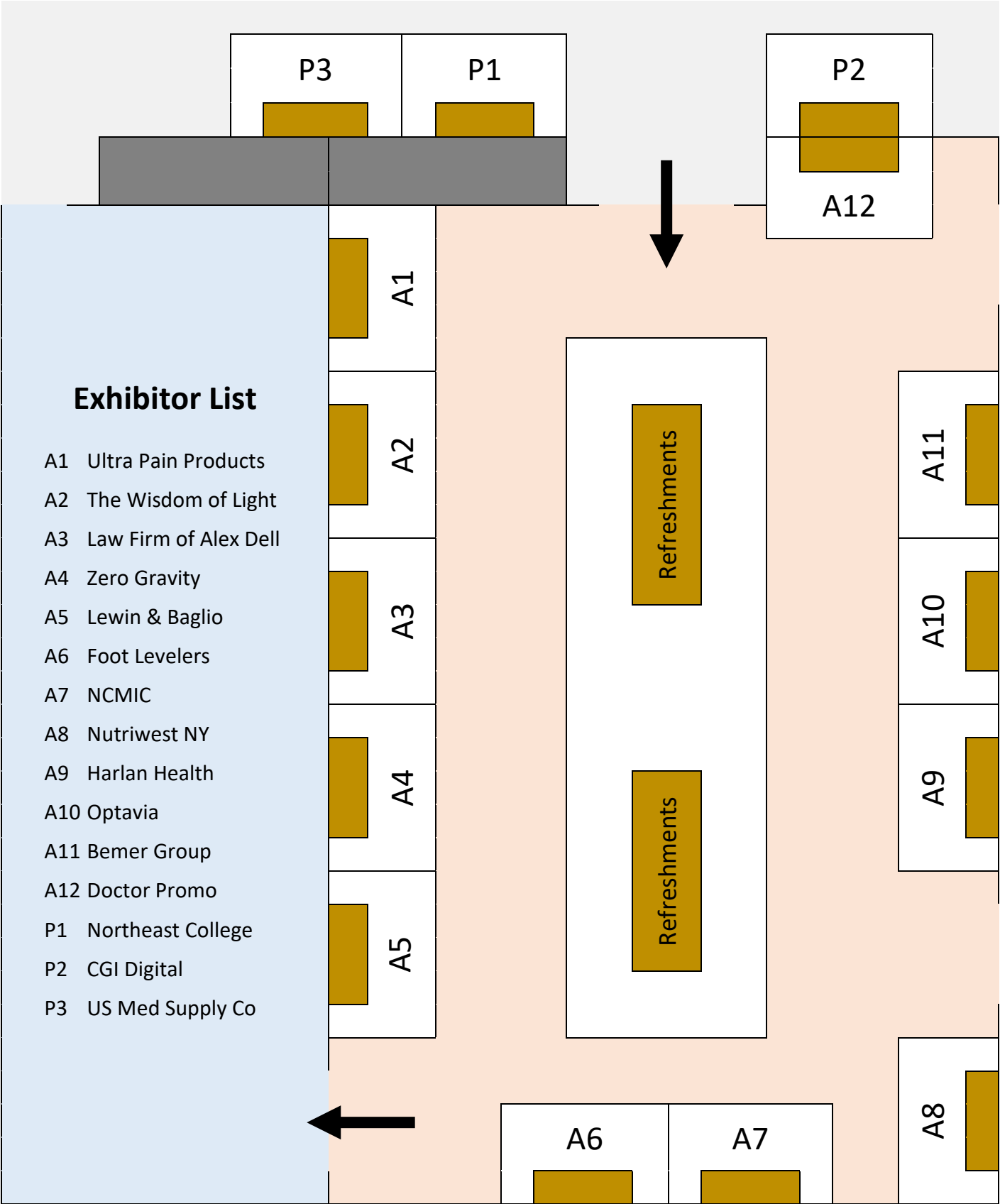
