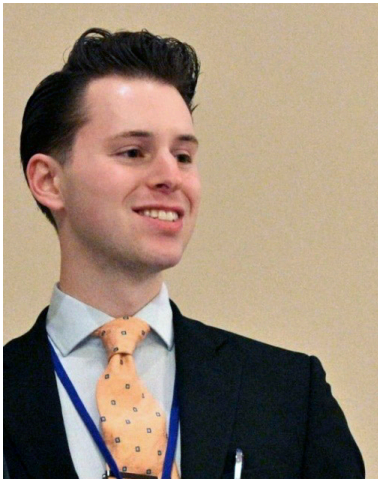
#### Awards

# NYSCA

New York's 2025-2026 budget was due on April 1. Certain policy issues delayed the final budget, as the Governor proposed a series of major policy changes that took some time for the Governor and Legislature to negotiate. On April 28, the Governor announced there was a general agreement on a budget deal between herself, the Senate and the Assembly but further negotiations were still needed to fill in the gaps of the general agreement and arrive at a final budget deal. The last of the budget bills were passed on Thursday, May 8, 37 days after its April 1 due date. This is the latest state budget since 2010.

The final budget totaled \$254 billion, which is \$2 billion more than was initially proposed by Governor Hochul. Several high-profile proposals, including discovery reform, a bell-to-bell ban of cell phones in schools, involuntary confinement rules, enhanced criminal penalties for those committing a crime while wearing a mask were included in the final budget. Also included were middle class tax credits, an increase in the child tax credit, free school breakfast and lunch for all New York schoolchildren, inflation refund checks that will be sent to 8.2 million New Yorkers, and \$400 million will be included for childcare vouchers.

While we have a final budget in place, it is likely that the Legislature will need to return in the fall to amend the enacted State budget to respond to any budgetary actions taken by the federal government. The federal government passed a continuing resolution in March that will keep the federal government functioning until September. The U.S. Senate and House of Representatives are now working on putting together a proposed federal budget. Nothing is finalized at this point but based on statements from leadership in both houses and President Trump, the federal government is contemplating significant funding cuts to state and local governments. The amount of these cuts, and which agencies and programs are most likely to be targeted, are not yet clear. Without clarity on the federal cuts, the State leaders in both houses and the Governor enacted a budget that is based on current funding numbers. The New York State leaders were clear that they didn't want to make preemptive cuts because there is no clear line of site on which areas should be targeted for cuts or how much in cuts will be needed.

There were not many items of specific interest to the chiropractic profession in the proposed budget, but we were monitoring several proposals related to workers' compensation. In the end, a proposal to allow medical and surgical residents and fellows to treat workers compensation patients was included as was a provision to require health insurers and health benefits plans to pay for treatment when workers' compensation treatment is being contested or denied without accepting liability. Proposals to automatically enroll all eligible healthcare providers in the workers' compensation system and to codify the Department of Financial Services workers' compensation treatment opinion were not included in the final budget. We will share any implementation updates of these provisions if we determine they will impact the profession or your patients.

Despite the delay in the budget, the NYSCA officers and the legislative co-chairs came to Albany on Tuesday, May 6 to discuss non-budget legislation of interest to chiropractic profession. Our conversation focused on four key pieces of legislation, the scope modernization bill sponsored by Assemblymember Sarah Clark and Senator Andrew Goundardes (A4706/S5860), the look back audit bill sponsored by Assemblymember Charles Lavine and Senator Jessica Scarcella-Spanton (A3365/S5209), which would limit the time period for lookback audits by insurance companies, the partnership bill sponsored by Assemblymember Crystal Peoples-Stokes and Senator Jessica Scarcella-Spanton (A2588/S3350), which would allow healthcare providers to form business partnerships with each other and medical doctors, and the virtual credit card bill sponsored by Assemblymember Alex Bores and Senator Jeremy Cooney (A3986/S2105), which would require disclosure and limitations on fees for payments by credit card or electronically by insurers to providers. We met with all of the bill sponsors as well as key committee chairs of the committees that will consider this legislation.

As you may recall, for the scope of practice legislation, our main legislative priority, we have a new Assembly sponsor following the retirement of our previous sponsor Assemblymember O'Donnell. It was a pleasure to meet our new sponsor, Assemblymember Sarah Clark from Rochester. She was supportive and enthusiastic to be sponsoring this legislation. We also met with our Senate sponsor, Senator Goundardes who was also very supportive for this legislation.

We also met with the Senate and Assembly chairs of the Higher Education Committee, which is the committee that reviews our scope of practice legislation. In the Assembly, there is a new committee chair, Assemblymember Alicia Hyndman. Both meetings were very positive, and both chairs seemed receptive to our bill and the changes we are seeking. In addition to the lobby day meetings, we also had conversations with the State Education Department (SED) as it was suggested that we ask for a technical review of the language to see if any changes were needed from their point of view. SED cannot support or oppose legislation, but they can provide

NGS encourages providers to submit claims electronically. Electronic Data Interchange (EDI) is an electronic communication method that offers effective, accurate and reliable transactions. Claims submitted electronically process faster than paper submission. For example, HIPAA-compliant electronic claims are held in the payment floor for 14 days whereas paper claims are held in the payment floor for 29 days.

## MARCH 27, 2025 CHANGES TO WC DME ALSO IMPACTS ALL DRAFT PARs

As noted in the following notice from the NYS Workers' Compensation Board, durable medical equipment (DME) prior authorization requests (PARs) which include an estimated cost will be noted on all subsequently issued Orders of the Chair. However, when the WC system is updated to accommodate this change, all draft PARs will be deleted. To avoid any disruptions, then you must have completed and submit any PAR drafts prior to Thursday, March 27th at 6pm.

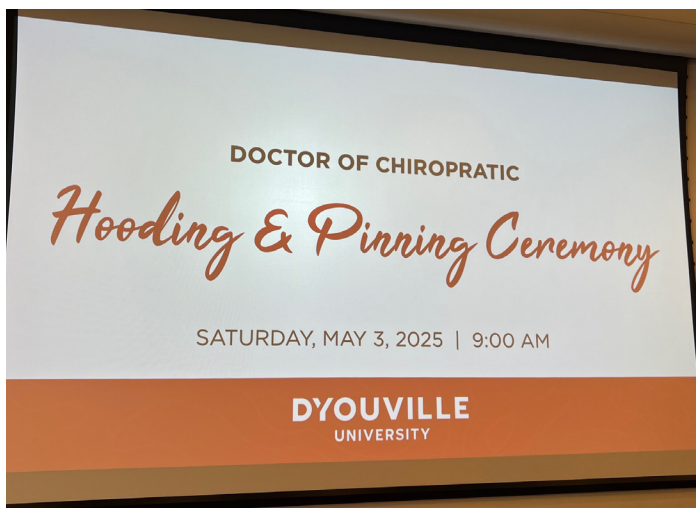

technical guidance on what should and should not be included and make recommendations about what language is used and how definitions are defined.

As a result of our lobby day meetings, and ongoing conversations with the legislature and key stakeholders, we learned that SED, the Senate and the Assembly all had some questions about the language and definitions used in our bill. It was recommended that we consider making a few changes to the bill, and we are working on those changes now. The recommended changes do not affect the intent of this legislation but rather consolidate and provide clear language that mirrors our education and training and is similar to neighboring states as it relates to the definition of the practice of chiropractic. In addition, all recommended removal of the title “chiropractic physician” as physician is clearly defined in New York as a medical doctor. Finally, all recommended removing the chiropractic assistant portion of the bill. This part of the bill creates an entirely new profession, and they would like each scope of practice bill to focus on one profession only. After we have achieved passage of the scope changes for the chiropractic profession, we will work with our sponsors to then introduce a bill for chiropractic assistants. With these recommended changes, the bill is streamlined and creates the changes we needed to reflect our education and training that has advanced so much since 1963.

For the other three bills we discussed on lobby, there appeared to be an understanding of the issues and great support for these bills and what appears to be a desire to work together to get things done. We feel that we are in a good place to make progress on several of our legislative priorities, and we will keep meeting with key legislators and stakeholders to try and pass these legislative priorities.

The State Board of Chiropractic meeting was held on Thursday, May 15 and was attended by myself and NYSCA Communications Secretary, Dr. Rae Smith. This was the last meeting for the current board secretary, Dr. Dolores Cottrell. Dr. Cottrell has been a fantastic board secretary and a wonderful advocate for the chiropractic profession. We wish her all the best in her retirement. We are pleased to welcome her replacement as Board Secretary, Dr. Steven Calderon and look forward to working with him on chiropractic issues. We shared an update with the board, and all those in attendance at the meeting, about our legislative efforts and outlined the changes that had been requested by the State Education Department, the Assembly and the Senate to the scope modernization bill. We also shared how we hope these changes will help the scope bill advance through the legislative process.

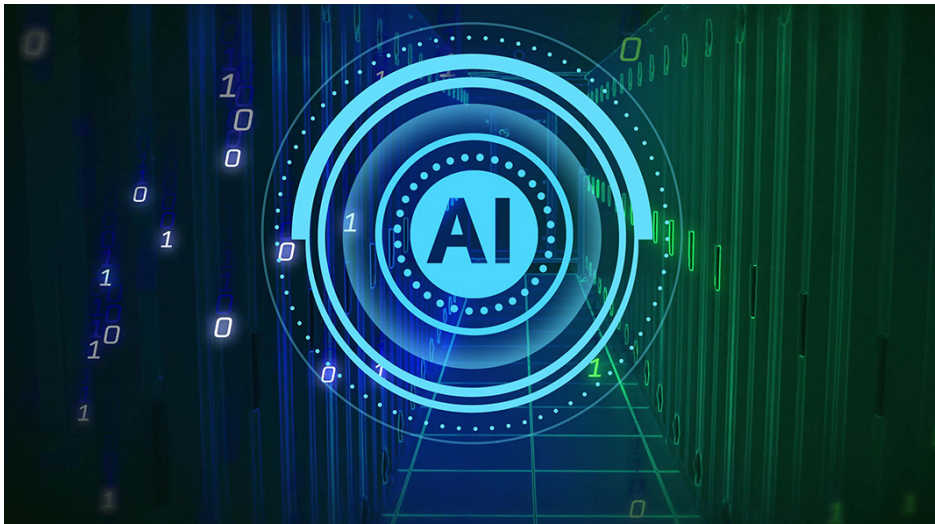

## UPDATE: CORPORATE TRANSPARENCY ACT: FINCEN REMOVES BOI REPORTING REQUIREMENT FOR U.S. ENTITIES

Consistent with the Department of the Treasury's March 2, 2025 announcement, FinCEN issued an interim final rule on March 21, 2025, which removed the beneficial ownership information ("BOI") reporting requirement for U.S. entities and its beneficial owners to FinCEN under the Corporate Transparency Act.

In the interim final rule, the definition of "reporting company" has been revised to mean only those entities formed under the law of a foreign country and that have registered to do business in the U.S. by filing a registration document with a secretary of state or similar office. Foreign entities that meet this new definition of "reporting company" are required to file a BOI report with FinCEN by the new deadline, if they do not meet an exemption. Additionally, the foreign entities are not required to report U.S. persons that are beneficial owners.

Under the interim final rule, reporting companies (or, foreign entities) must follow the following reporting deadlines:

# When an Associate Leaves: Patient Notification Obligations for New York Chiropractors

Understanding your professional and legal duties to ensure continuity of care and patient trust.

## Introduction

When an associate chiropractor leaves a practice—whether to pursue new opportunities, open their own office, or for any other reason—it can create uncertainty for both patients and providers. In New York State, chiropractors are bound by professional standards and legal obligations to ensure patients are informed, protected, and empowered to make their own decisions about ongoing care. Here is what chiropractors need to know to manage provider transitions smoothly and ethically.

## 1. Why Patient Notification Matters

Patient notification is a cornerstone of ethical and compliant chiropractic practice. When a provider departs, patients may be left without clear guidance unless proactive steps are taken. The New York State Education Department (NYSED) and the Board of Regents consider it unprofessional conduct to abandon patients or fail to ensure continuity of care. Proper notification builds trust, honors patient autonomy, and minimizes disruption.

## 2. Who Should Be Notified?

While you are not required to notify all patients, you should ensure that the following groups are informed:

- Patients directly treated by the departing associate
  - Patients with upcoming appointments scheduled with the associate
- Posting a general notice in the office reception area or on your website may also help notify patients who may have interacted with the associate occasionally.

## 3. How to Notify Patients

Communications should be professional, factual, and neutral in tone. Common notification methods include:

- **Written Notices:** Send a letter or email to the affected patients. Include the associate's final working day, contact information (if appropriate), and options for continued care.
- **In-Office Signage:** Display a discreet, clear notice in the waiting area.
- **Phone or Verbal Notification:** Train front-desk staff to communicate changes accurately and respectfully.

Avoid sharing the reasons for the departure and focus solely on supporting the patient's care decisions.

## 4. Ensuring Patient Choice and Access to Care

Patients have the right to choose their healthcare provider. If a patient wishes to follow the departing associate to a new location, the current practice must not obstruct that decision. Staff should:

- Clearly inform patients of their right to choose
- Avoid discouraging or influencing the patient's decision
- Document any written request to transfer medical records

Respecting patient autonomy is both a legal requirement and a hallmark of professional integrity.

## 5. Handling Medical Records Requests

Under New York Public Health Law §18, patients are entitled to access their medical records. Key guidelines include:

- Patients must submit a signed written request
- You may charge up to \$0.75 per page for copies
- Records may only be sent to the associate's new practice with patient's written authorization

Be sure to log and respond promptly to all requests to remain compliant.

## 6. Avoiding Unprofessional Conduct

According to Part 29 of the Rules of the Board of Regents, chiropractors must avoid false, misleading, or disparaging communications. During transitions:

- Do not make negative remarks about the departing associate
- Avoid implying that patients cannot continue care elsewhere
- Maintain a respectful, neutral tone in all interactions

Following these guidelines protects your practice and demonstrates professionalism.

## 7. Best Practices for a Smooth Transition

To minimize disruption and confusion, prepare well in advance:

- Hold a staff meeting to review communication protocols
- Develop a script for addressing common patient questions
- If possible, consider jointly signing a departure letter to demonstrate mutual respect

Consistency, clarity, and empathy go a long way in maintaining patient confidence.

Associate departures are a natural part of chiropractic practice. By understanding your responsibilities under New York law and professional ethics, you can ensure a smooth transition for your patients. Prioritizing clear communication, honoring patient choice, and handling records with care will help protect your practice, your patients, and your reputation.

Burial with Military Honors, will take place at St. Peter's Cemetery in Poughkeepsie.



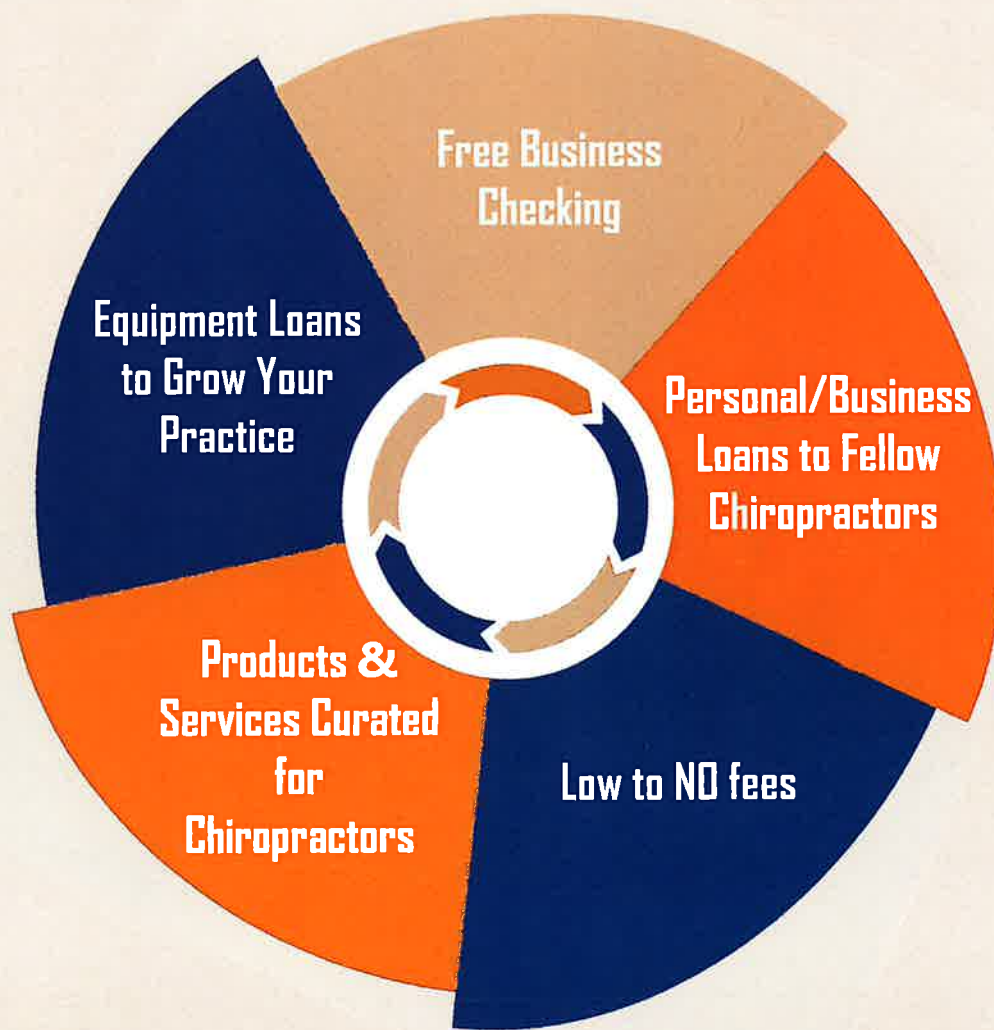
## Geoffrey J. Gerow, DC



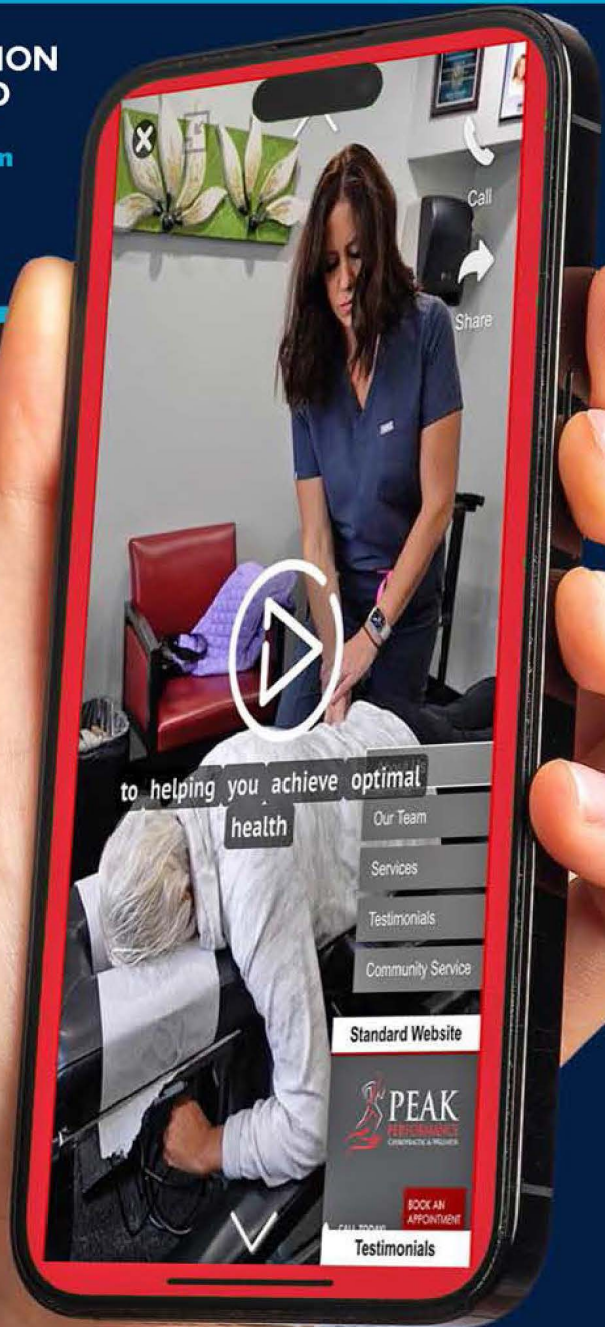

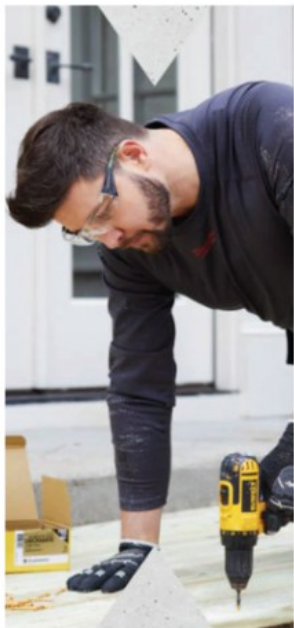
